PART I. General Expectations

Allen 6th Grade Campus agrees to implement the following statutory requirements:

PART II. Description of how Allen 6th Grade Campus will implement the required components of the campus Title I Parent Engagement Plan.

1. Allen 6th Grade Campus will take the following actions to involve parents in the joint development of its campus Parent Engagement Plan under section 1112 of the ESEA:

- Establish the campus Parent Engagement Advisory Council adequately represented by parents of attending children, administrators and Title I personnel. Other council members may include community members and students.
- Annually hold a meeting to review, discuss, and revise the school's Title I Parent Engagement Plan.
 - Parents will be selected by the principal with staff input. The meeting will be held with the SBDM committee annually, and language support will be provided if needed.

2. Allen 6th Grade Campus will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA:

- Hold committee meetings, composed of parents and school staff, to review the Campus Improvement Plan.
 - Our SBDM committee which includes parent and community members will review the Campus Improvement Plan annually. Language support will be provided if necessary.
- Provide Title I, Part A school staff support in enhancing their School Campus Improvement Plans.
 - Professional development for staff will take place during planned district or campus staff development and after school when needed.
- Administer the Title I campus Parent Engagement Survey designed to identify the type of support, information, and resources that parents' need included in their Campus Improvement Plan and campus Parent Engagement Plan to better support their children's education and become more involved in their school.

3. Allen 6th Grade Campus will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in the Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting and will encourage them to attend. These informative meetings may include, but are not limited to, the following:

- Allen 6th Grade Campus has several programs we offer to inform parents of Title I, Part A. There is information available to parents during registration as well as a Meet and Greet during the first week of school. We also host a Tailgate party with Mann Middle School during the first few weeks of school. In the spring we have an Open House for a mid-year update.

4. Allen 6th Grade Campus will, in a timely manner, provide parents of participating children information about Title I, Part A programs that includes a description and explanation of the

school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet:

- During the Fall Open House parents will be provided this information in writing.

5. Allen 6th Grade Campus will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible. These may include, but are not limited to, the following:

- Semester Parent Involvement meetings, or as needed per parent request via the principal or Parent Liaison.

6. Allen 6th Grade Campus will provide each parent an individualized student report regarding the performance of their child on the state assessment in at least math, language arts and reading by:

- Information flyers will be sent home and posted at the school in English and Spanish for instructions on how to access STAAR scores online. Phone call out reminders will also be sent.

7. Allen 6th Grade Campus will provide assistance to parents of children served by the school, as appropriate, on important topics. These may include, but are not limited to, the following: STAAR, Skyward Family Access

- Reviewing and understanding the state's academic content standards.
- Reviewing and understanding the state's student academic achievement standards.
- Reviewing and understanding the state and local academic assessments including alternative assessments.
- The requirements of Title I, Part A.
- How to monitor their child's academic progress.
- How to work with educators.
- Other topics that received strong parent interest as reflected by the Title I school Parent Engagement Survey.

8. Allen 6th Grade Campus will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parent engagement. These may include, but are not limited to, the following:

- Library Night/Literacy Night/Book Fair
- Family Fun Night to visit various departments and learn how to help their children
- Science Night
- Discovery Center Night
- Skyward Parent Training

9. Allen 6th Grade Campus will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools. These efforts may include, but are not limited to, the following:

- Parent on SBDM, Parent Involvement meetings each semester

10. Allen 6th Grade Campus will, to the extent feasible and appropriate, coordinate and integrate Title I parental engagement programs and activities with public preschool and other similar programs (e.g., Head Start, Parents as Teachers, etc.) that encourage and support parents in more fully participating in the education of their children. These efforts may include, but are not limited to, the following:

- Parent orientation night for incoming 6th graders in the spring prior to their arrival, to review electives and Pre-AP as well as an overview of our campus.
- All incoming 6th graders will be invited to participate in Allen's summer reading program. Representatives from our campus will meet with all the 5th graders who will be at our campus next year to invite them to attend and provide information and dates of the events.

11. Allen 6th Grade Campus will take the following actions to ensure that information related to the school, parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand. These may include, but are not limited to, the following:

- Many of our teachers currently speak Spanish as well as our secretary. In the event these teachers are unavailable to interpret, the ELSA translation device is utilized to communicate with our parents who require translation. When possible notes and phone call out are also sent home in Spanish.

PART III. Discretionary Components of the Allen 6th Grade Campus Title I Parent Engagement Plan

Allen 6th Grade Campus may provide discretionary activities that build parents' capacity for engagement in Title I schools and the school system to support their children's academic achievement; these may include, but are not limited to, the following:
